Dear San Marino Rotarians,

It was my pleasure to serve as President of the Rotary Club of San Marino for 2016-17 and I am pleased to help provide this annual report on San Marino Rotary Charities.

Our Rotary Club of 114 members provided support to community organizations and local schools as well as to international projects through our charitable 501(c)(3) non-profit organization, San Marino Rotary Charities.

Rotary Charities is mainly supported by our Rotary Club Members' contributions and from our Club's participation in the San Marino Motor Classic.


On behalf of all our Rotary Club members, we express thanks and gratitude to Aaron Weiss, Chairman, San Marino Motor Classic, for partnering with our Club on this major fund-raising effort which allows us to support all the major projects and endeavors sponsored by our Club.

For 2016-17, Rotary Charities has distributed \$136,982. A surplus of revenues over disbursements of \$9,681 in 2016-17 remain which will be added to the Carryover Operating Fund going into 2017-18.

The 2017 Motor Classic funds is anticipated to provide \$104,000. This consists of an anticipated \$80,000 distribution directly from the Motor Classic, plus \$24,000 net proceeds from our ticket sales efforts for the Motor Classic event. These funds will be used in our 2017-18 Rotary Year.

The Annual Report highlights details on Rotary Charities' many charitable programs for 2016-17 that we have supported. Rotary Club members may contact the Charities' Chief Financial Officer for more detailed funding information.

We continue to be motivated by the 2016-17 Rotary International Theme, 'Rotary serving Humanity'.




# **2016 – 17 Programs:**

# **Summary of Operating Revenue Sources:**



A total of \$146,553 was received from a variety of sources. The primary source of the charitable funds for distribution is the annual San Marino Motor Classic. San Marino Rotarians worked countless hours to promote, organize and actually work the event. The distribution of these monies becomes the primary responsibility of the San Marino Rotary Charities Board.

### **Summary of Overall Distribution of Funds:**



A total of \$136,982 was distributed in the 2016-17 year. Because San Marino Rotary is a 100% volunteer organization, less than 1% of this total went to Administrative Costs.

Of the total charitable funds distributed, 78% remained in the San Marino and nearby communities; 22% was used for international projects.

Funds are distributed through a variety of ways. Committees are appointed and charged with specific areas of concentration. These committees review funding requests to ensure that pre-established criteria are met. Committees then make recommendations to the Charities Board for final approval. Committee activities are governed by the San Marion Rotary Charities Policies and Procedures.

\*The William "Bill" G. Steele, Jr. Mini-Grant program provides funding to schoolteachers with innovative programs to enrich student's classroom experience.

These funds are awarded to schools that would not otherwise have sources of funding for the proposed classroom projects. All teachers at both public and private schools within the San Marino School District boundaries are eligible for Mini-Grants. Once a project is complete, the teacher and student representatives are invited to present their project at a San Marino Rotary Club meeting.
